#### **HEALTH AND FITNESS LEVEL:**

**Trip participants should be healthy and active.** Erawan Ventures Inc. trips are available to anyone in good health and in reasonably good shape. By sending your non-refundable deposit, you certify that you do not have any physical conditions or disabilities that would create a hazard for you or any other participants on the trip. This trip requires a moderate level of fitness and mobility and you must be able to look after your own luggage for airport handling. (Porterage is available for all transfers). If your medical situation changes after signing this form and prior to the trip departure, you are obligated to advise us in case changes need to be made.

Any person who requires assistance with walking, dining or personal needs must have a companion to assist them. Please consult your physician and International Travel Clinic for pre-departure health advice.

Please also note that due to topography and the nature of the terrain, stairs, winding roads and other unusual conditions may occasionally be encountered during our daily activities. Sensitivity to the needs and comfort of our clients is however always our highest priority.

**Who should come on this Bali trip?** This trip is perfect for women of all ages with a sense of fun and adventure and interested in embracing exotic destinations and cultures. Come on your own or bring your favourite female travelling companion and share the experience of the 'real' Bali with a small, intimate group.

**SINGLE SUPPLEMENT:** Singles who wish to share with another guest should request this at the time of booking; reservations will be designated as a 'single-share-if-possible' basis. The single price is charged initially; but if another guest is willing to share, the difference between the single supplement price and the per person twin price will be refunded. Due to the small group size, single-shares cannot be guaranteed.

## **TRAVEL TERMS AND CONDITIONS:** (Please read carefully)

**RESERVATION INFORMATION AND CONDITIONS:** A non-refundable deposit of \$800CAD/USD is required at time of booking to secure a space. An invoice, Bali Travel Tips, detailed pre-departure information, "what to bring" information and a personalized itinerary will be sent to you prior to departure. The balance is due 70 days prior to trip departure. Prices quoted are based on "twin share" travelling and a single supplement option is also available.

**CANCELLATION:** Land cancellation fees (days prior to departure):

- 70 days or more: \$800 CAD/USD non-refundable deposit.
- 0 to 70 days: 100% of land cost is non-refundable.
- No refunds on no-shows or unused portions of trips.

All prepaid airfare is subject to current airline and ticket cancellation policies. See invoice for details.

**RESPONSIBILITIES OF TRIP MEMBERS:** Participants have certain responsibilities to Erawan Ventures Inc. and to other trip members. Each traveller is responsible for understanding the conditions implied in the trip Itinerary and committing to the trip so that it is appropriate to their interests and abilities, and for preparing for the trip by studying the trip itinerary and supplemental trip information sent by Erawan Ventures Inc. Erawan Ventures Inc. reserves the right to terminate the tour for any person or persons who are abusive of others or whose behaviour disrupts the tour.

**INSURANCE:** Out of country health insurance is mandatory and trip cancellation/interruption is highly recommended. We offer a comprehensive Deluxe Tour Package, which includes medical and cancellation insurance. Please contact our office for details. The cost of the insurance is non-refundable once the policy has been issued.

**PASSPORTS:** All participants are required to have a valid passport that must be valid for 6 months beyond the completion of the trip, and must have sufficient blank pages for all necessary entry/exit stamps. Participants are responsible for any visas or additional documentation they may require, depending on their nationality, for entry into the countries visited or transited.

**LIMITATIONS OF LIABILITY:** Erawan Ventures Inc., of Calgary, Alberta, hereafter referred to as "the company", acts as agents for the various owners or contractors, providing hotels, means of transportation or other services. Issuance and acceptance of the tour documents shall be deemed to be consent to the condition that the company shall not be liable or responsible in any way for any personal or property loss, damage or injury, however caused or arising. The passenger understands that during the course of the trip certain risks and dangers may occur, including but not limited to the hazards of travelling in general. The passenger agrees to assume all risks associated with the journey and agrees that no liability will attach to the company or its outfitters, employees or agents, or to any member of the tour group in respect of death, personal injury, illness or delay of the passenger, or for any loss of or damage to the property of the passenger during the course of the trip, howsoever caused. The company reserves the right to decline, to accept, or to retain any person as a member of any party at any time.

**CLAIMS:** Any claims arising out of or relating to any Erawan Ventures Inc. tour must be made on pain of nullity in writing and within 30 days of the return of the passenger from their holiday. Any legal proceeding which is properly subject to the jurisdiction of Canada and any Canadian province must be instituted on the pain of nullity in the judicial district of Alberta exclusively, and within six months after the return of the passenger from their Erawan Ventures Inc. trip.
