HEALTH AND FITNESS LEVEL:

Trip participants should be healthy and active. Erawan Ventures Inc. trips welcome those in good health and able to participate in an active itinerary. By purchasing this tour, you certify that you do not have any physical conditions or disabilities that would create a hazard for you or any other participants. Our trips require a moderate level of fitness and mobility and you must be able to look after your own luggage for airport handling. (Porterage is available for all transfers). If your medical situation changes after signing this form and prior to trip departure, you are obligated to advise us in the event changes need to be made. If you have concerns, please contact Cathy Gotfried at Erawan Travel/Babes in Bali tours.

Any person who requires assistance with walking, dining or personal needs must have a companion to assist them. Please consult your physician and International Travel Clinic for pre-departure health advice.

Please also note that due to topography and the nature of the terrain, stairs, winding roads and other unusual conditions may occasionally be encountered during our daily activities. Sensitivity to the needs and comfort of our clients is however always our highest priority.

Who should come on this Bali trip? This trip is perfect for women of all ages with a sense of fun and adventure and interested in embracing exotic destinations and cultures. Come on your own or bring your favourite female travelling companion/s and share the experience of the 'real' Bali with a small, intimate group. Everything will be looked after, so you just need to show up on time and be ready to explore the splendour of Bali and its' people!

SINGLE SUPPLEMENT: Singles who wish to share with another guest should request this at the time of booking; reservations will then be designated as a 'single-share-if-possible' status. The single price is charged initially; but if another guest is willing to share, the difference between the single supplement price and the per person twin price will be refunded. Due to the small group size, single-shares cannot be guaranteed, however we will always endeavour to accommodate "pairing" requests to the best of our ability.

WEATHER: Most parts of Indonesia are hot and humid throughout the year. It usually takes at least two weeks to adapt to the hot climate. Swelling of the feet and ankles is common, as are muscle cramps caused by excessive sweating. Even on a cloudy day sunburn can occur rapidly, especially near the equator. Don't get burned and stay hydrated. Bottled water will be provided on all of our tours and transfers and is readily available at our hotels and in convenience stores.

TRAVEL TERMS AND CONDITIONS: (Please read carefully)

RESERVATION INFORMATION AND CONDITIONS: A non-refundable deposit of \$1000CAD/USD is required at time of booking to secure a space. An invoice, detailed pre-departure and "what to bring" information and personalized itinerary will be sent to you prior to departure. The balance is due by AUGUST 5 or AUGUST 19, 2025 respectively. Verbal authorization of the use of your credit card commits you to your reservation, with or without a signed a credit card form. Prices quoted based on "twin share" room occupancy while a single supplement option is also available at time of booking.

CANCELLATION: Land cancellation fees (days prior to departure):

- 70 days or more: \$1000 CAD/USD non-refundable deposit.
- 0 to 70 days: 100% of land cost is non-refundable.
- No refunds on no-shows or unused portions of trips.

All prepaid airfare is subject to current airline, booking agent or ticket cancellation policies. See invoice for details.

RESPONSIBILITIES OF TRIP MEMBERS: Participants have certain responsibilities to Erawan Ventures Inc. and to other trip members. The Company is committed to providing the best service and experience possible. Each traveller is responsible for understanding the conditions implied in the trip Itinerary, and in committing to the trip, confirm that it is appropriate to their interests and abilities and acknowledge that preparation for the trip includes reviewing the trip itinerary and supplemental trip information provided by Erawan Ventures Inc.. Erawan Ventures Inc. reserves the right to terminate the tour for any person or persons who are abusive of others or whose behaviour is disruptive. Participants leaving the tour for any reason will not receive refunds for unused services/compensation for costs incurred as a result of their departure.

INSURANCE: Out of country health insurance (with a minimum of \$500,000 CAD/USD evacuation/repatriation coverage, including personal injury and all forms of medical expense.) is mandatory. Trip cancellation/interruption insurance is highly recommended.

PASSPORTS: All participants are required to have a valid passport that's also valid for 6 months beyond the date of return and must have sufficient blank pages for all necessary entry/exit stamps. The passport also needs to be in good condition, meaning no ripped, torn or worn pages and no water damage.

DOCUMENTATION: Participants are responsible for any visas or additional documentation they may require, depending on their nationality, for entry into the countries visited or transited. Specific passport, visa, vaccination, health requirements and other immigration requirements are your responsibility. The Company does not accept responsibility if you cannot travel because you have not complied with the latest requirements.

LIMITATIONS OF LIABILITY: Erawan Ventures Inc., of Calgary, Alberta, hereafter referred to as "the company", acts as agents for the various owners or contractors, providing hotels, means of transportation or other services. Issuance and acceptance of the tour documents shall be deemed to be consent to the condition that the company shall not be liable or responsible in any way for any personal or property loss, damage or injury, however caused or arising. Group participants understand that during the course of the trip certain risks and dangers may occur, including but not limited to the hazards of travelling in general. Participants agree to assume all risks associated with the journey and agree that no liability will attach to the company or its directors, outfitters, employees or agents, or to any member of the tour group in respect of death, personal injury, illness or delay, or for any loss of or damage to the property of the Participant during the course of the trip, howsoever caused. The company reserves the right to decline, to accept, or to retain any person as a Participant in the group at any time.

CLAIMS: Any claims arising out of or relating to any Erawan Ventures Inc. tour must be made on pain of nullity in writing and within 30 days of the termination of the participants tour. Any legal proceeding which is properly subject to the jurisdiction of Canada and any Canadian province must be instituted on the pain of nullity in the judicial district of Alberta exclusively, and within six months after the return of the passenger from their Erawan Ventures Inc. trip.
